FINAL ORDER

THIS CAUSE came before the State of Florida, Office of Insurance Regulation ("Office"), being authorized and directed to administer and enforce the Florida Insurance Code, for consideration and final agency action, hereby enters this Final Order as authorized by the provisions of the Florida Insurance Code and Chapter 120, Florida Statutes (2022), to Ivantage Insurance Solutions, LLC (hereinafter referred to as "Ivantage").

FINDINGS OF FACT

1. The Office served an Amended Administrative Complaint ("Complaint") on Richard Dorfman, Managing Member of Ivantage, on or about July 24, 2019. (The Complaint and its General

Allegations and various Counts are incorporated by reference in this Final Order and attached hereto as Exhibit A).

- 2. On or about November 1, 2019, Ivantage went into receivership.
- 3. On or about October 12, 2022, the Office served the Amended Administrative Complaint on Ivantage's court-appointed receiver, Michael Goldberg, Esq. ("Receiver").
- 4. On or about October 21, 2022, the Office received a Uniform Certificate of Authority Application Affidavit of Lost Certificate of Authority ("Affidavit") from Ivantage's Receiver providing that the Receiver could not locate the Certificate of Authority ("COA") and it is considered lost, misplaced or destroyed, it is therefore impossible for Ivantage to surrender the COA to the Office. (The Affidavit is attached hereto as Exhibit B).

ORDER

Based on the foregoing Findings of Fact, careful consideration of the entire record, the Affidavit submitted by the Receiver, relevant statutes, and rules, and being otherwise fully advised in the premises, it is hereby **ORDERED** that:

5. Ivantage's Certificate of Authority No. 17-815213148, issued on November 29, 2017, is lost, misplaced, or destroyed as stated in the Affidavit executed by Ivantage's Receiver on or about October 17, 2022, and is accepted as surrendered.

Review proceedings must be instituted by filing a Petition or Notice of Appeal with the General Counsel, acting as the agency clerk, at 200 East Gaines Street, Tallahassee, FL 32399-4206, and a copy of the same and filing fee with the appropriate District Court of Appeal within thirty (30) days of the rendition of this Order.
