CONSENT ORDER

THIS CAUSE came on for consideration as the result of TEPCO PREMIUM FINANCE, L.L.C.'s ("TEPCO") violation of one or more provisions of the Florida Insurance Code as outlined in their 2022 Market Conduct Examination conducted by the FLORIDA OFFICE OF INSURANCE REGULATION ("OIR"). Following a complete review of the entire record, and upon consideration thereof, and being otherwise fully advised in the premises, the OIR hereby finds as follows:

- 1. The OIR has jurisdiction over the subject matter and the parties herein. TEPCO is a premium finance company authorized to transact business in Florida and subject to regulation by the OIR, pursuant to the Florida Insurance Code.
- 2. On or about April 26, 2023, the OIR conducted a market conduct examination of TEPCO.
- 3. The OIR documented the following violations of the Florida Insurance Code by TEPCO:
 - Failure to timely issue a refund after insured's account has been overpaid (Section 627.848(1)(e), Florida Statutes); and

- b. Failure to maintain a copy of the certificate of mailing of notice of intent to cancel the insurance contract (Rule 69O-196.002, Florida Administrative Code).
- 4. Section 627.848(1)(e), Florida Statutes, provides that, whenever a financed insurance contract is canceled, a premium finance company shall, within 15 days after an account has been overpaid, either refund to the insured for the insured's benefit any refund due on his or her account or, if the refund is sent or credited to the agent, return or credit to the agent the amount of the overpayment and notify the insured of the refunded amount.
- 5. In two (2) instances, the OIR documented that TEPCO failed to timely issue a refund after a financed insurance contract was canceled and the account was overpaid.
- 6. Rule 690-196.002, Florida Administrative Code, provides that written notice be mailed to each insured shown on the premium finance agreement of the intent of the premium finance company to cancel the insurance contract, and requires obtaining a certificate of mailing.
- 7. In fifty (50) instances, the OIR documented that TEPCO failed to maintain in its files a copy of the certificate of mailing reflecting that the notice of intent to cancel was sent to the last known address of the insured as required by Rule 69O-196.002, Florida Administrative Code.
- 8. Section 627.832(1)(b), Florida Statutes, provides that the OIR may deny, suspend, revoke, or refuse to renew any license if it finds that the licensee has violated any provision of Chapter 627, Part XV, or any rule of the commission.
- Section 627.833, Florida Statutes, provides that if the OIR finds that one or more grounds exist for the discretionary revocation or suspension of a license issued under Chapter

- 627, Florida Statutes, the OIR may, in lieu of such revocation or suspension, impose a fine upon the premium finance company.
- 10. The OIR finds that TEPCO has violated Section 627.848(1)(e), Florida Statutes, and Rule 690-196.002, Florida Administrative Code.
- 11. TEPCO agrees that within 10 days of the execution of this Consent Order, TEPCO shall pay an administrative fine in the amount of \$5,200 U.S. Dollars ("USD") and administrative costs in the amount of \$1,000 U.S. Dollars ("USD") to the OIR. TEPCO shall send its payment to the address reflected on the invoice attached hereto as "Exhibit A."
- 12. Any deadlines, reporting requirements, other provisions, or requirements set forth in this Consent Order may be altered or terminated by written approval of the OIR. Such approval must be requested in writing prior to any proposed deviation from the terms of this Consent Order.
- 13. TEPCO agrees that, upon execution of this Consent Order, failure to adhere to one or more of the terms and conditions contained herein may result, without further proceedings, in the OIR suspending, revoking, or taking other administrative action as it deems appropriate upon TEPCO's license in this state in accordance with Sections 120.569(2)(n) and 120.60(6), Florida Statutes.
- 14. TEPCO additionally agrees that, upon execution of this Consent Order, failure to adhere to one or more of the terms and conditions contained herein may be considered willful and subject TEPCO to appropriate penalties and fines.
- 15. TEPCO additionally agrees that any future violations of the statutes or rules named herein may be deemed willful, subjecting TEPCO to penalties as the OIR deems appropriate.

- 16. TEPCO expressly waives a hearing in this matter, the making of findings of fact and conclusions of law by the OIR, and all further and other proceedings herein to which it may be entitled by law or rules of the OIR. TEPCO hereby knowingly and voluntarily waives all rights to challenge or to contest this Consent Order in any forum available to it, now or in the future, including the right to any administrative proceeding, state or federal court action, or any appeal.
 - 17. Except as noted above, each party to this action shall bear its own costs.
- 18. The parties agree that this Consent Order shall be deemed to be executed when the OIR has signed and docketed a copy of this Consent Order bearing the notarized signature of the authorized representative of TEPCO.

WHEREFORE, the agreement between TEPCO PREMIUM FINANCE, L.L.C., and the FLORIDA OFFICE OF INSURANCE REGULATION, the terms and conditions of which are set forth above, is APPROVED.

All terms and conditions contained herein are hereby ORDERED.
