I shared your question with our Legal/Management team and was advised that both forms (1655 and 1802) were designed for use with personal residential policies, not commercial residential. In fact, s. 627.711, F.S. specifically mentions personal lines residential policies when it mandates that the Office develop the notification form (1655).

At this time, the forms would not be applicable for inspection of commercial residential properties or for calculating discounts for those policies.
