

CONSENT ORDER

THIS CAUSE came on for consideration as the result of an agreement between ASSURITY LIFE INSURANCE COMPANY (hereinafter referred to as "ASSURITY LIFE") and the OFFICE OF INSURANCE REGULATION (hereinafter referred to as the "OFFICE"). Following a complete review of the entire record, and upon consideration thereof, and being otherwise fully advised in the premises, the OFFICE hereby finds as follows:

1. The OFFICE has jurisdiction over the subject matter of, and the parties to this proceeding.
2. ASSURITY LIFE is a foreign insurer authorized to transact life and health insurance business in the State of Florida and is subject to the jurisdiction and regulation of the OFFICE pursuant to the Florida Insurance Code and the Florida Administrative Code.
3. a. Based upon the OFFICE's review of ASSURITY LIFE's accident only product, Forms L T02 (FL) and AAW-A117 FL and associated riders, the OFFICE determined that the company had not timely submitted the annual rate filings where indicated in Exhibit A, attached, as required by Section 627.410(7)(a), Florida Statutes, for that block of business for the years 2003, 2004, and 2005.

b. Based upon the OFFICE's review of ASSURITY LIFE's disability income product, Forms AAW-D112 FL and A-D109 (FL) and associated riders, the OFFICE determined that the company had not timely submitted the annual rate filings where indicated in Exhibit A, attached, as required by Section 627.410(7)(a), Florida Statutes, for that block of business for the years 2002, 2003, 2004, and 2005.

4. ASSURITY LIFE has submitted and the OFFICE has acknowledged all filings referred to in paragraph three (3) above, therefore, as of the date of execution of this Consent Order, ASSURITY LIFE is in compliance with Section 627.410(7)(a), Florida Statutes.

5. ASSURITY LIFE acquired disability income blocks of business, (hereinafter referred to "blocks of business"), between 1997-2003, from three (3) different insurers, Time Insurance Company, now known as Fortis Insurance Company, American Network Insurance Company, and Nationwide Insurance Company.

6. a. Section 627.410(7), Florida Statutes, states in pertinent part that "[e]ach insurer subject to the requirements of subsection (6) shall make an annual filing with the office no later than 12 months after its previous filing, demonstrating the reasonableness of benefits in relation to premium rates."

b. Section 627.410(3), Florida Statutes, states that "[t]he office may, for cause, withdraw a previous approval. No insurer shall issue or use any form disapproved by the office, or as to which the office has withdrawn approval, after the effective date of the order of the office."

7. ASSURITY LIFE agrees that upon the execution of this Consent Order, it shall be subject to the following terms and conditions:

a. For the Accident Only product, ASSURITY LIFE shall pay within thirty (30) days of issuance of this Consent Order an administrative fine in the amount of Two Thousand Five Hundred Dollars (\$2,500) for each of the three (3) years that it was in violation of Section 627.410, Florida Statutes, for a total of Seven Thousand Five Hundred Dollars (\$7,500).

b. For the Disability Income product, ASSURITY LIFE shall pay within thirty (30) days of issuance of this Consent Order an administrative fine in the amount of Two Thousand Five Hundred Dollars (\$2,500) for each of the four (4) years that it was in violation of Section 627.410, Florida Statutes, for a total of Ten Thousand Dollars (\$10,000).

c. ASSURITY LIFE shall pay, within thirty (30) days of issuance of this Consent Order, administrative costs in the amount of Three Thousand Dollars (\$3,000).

d. For any future rate increase filings greater than ten percent (10%) made with the OFFICE related to the products addressed above in paragraphs 3.a. or 3.b., ASSURITY LIFE agrees that the rate increase(s) may be phased in over a period of years, not to exceed the number of years ASSURITY LIFE was in violation of Section 627.410, Florida Statutes, as determined by the OFFICE.

e. ASSURITY LIFE agrees to freeze its rates on the acquired blocks of business referred to in paragraph five (5) at the rates currently in effect for such policyholders, and the OFFICE agrees that ASSURITY LIFE will not be required to submit annual filings pursuant to Section 627.401(7), Florida Statutes, in the future on such acquired blocks of business. Such rate freeze shall only apply to ASSURITY LIFE's acquired blocks of business referred to in paragraph five (5) of this Consent Order.

8. This Consent Order fully and completely resolves all matters pending before and with the OFFICE related to forms, policies, riders, and products with respect to the filings referred to in paragraphs three (3) and five (5) of this Consent Order.

9. ASSURITY LIFE is hereby placed on notice of the requirements of the above-referenced sections of law and agrees that any future violations of these sections may be deemed willful, subjecting ASSURITY LIFE to appropriate penalties. Future violations, as used in this paragraph, refers to failure to timely make filings required under Section 627.410(7)(a), Florida Statutes, due on or after the date of this Consent Order.

10. ASSURITY LIFE affirms that all representations and requirements set forth herein are material to the issuance of this Consent Order. Violation of any part of this Consent Order shall constitute a violation of a lawful order of the OFFICE and may subject ASSURITY LIFE to one or more of the administrative remedies available under the Florida Insurance Code or other applicable law.


11. ASSURITY LIFE expressly waives its right to a hearing in this matter, the making of Findings of Fact and/or Conclusions of Law by the OFFICE, and all further and other proceedings herein to which the parties may be entitled by law or rules of the OFFICE. ASSURITY LIFE hereby knowingly and voluntarily waives all rights to challenge or to contest this Consent Order, in any forum now or in the future available to it, including the right to any administrative proceeding, circuit or federal court action, or any appeal.

12. The parties agree that this Consent Order shall be deemed to be executed when the OFFICE has executed a copy of this Consent Order bearing the signatures of ASSURITY LIFE and/or its authorized representative under the seal of a notary public, notwithstanding the fact that the copy may have been transmitted to the OFFICE electronically.

13. Except as noted above, each party to this action shall bear its own costs and attorney's fees.

THEREFORE, the agreement between ASSURITY LIFE INSURANCE COMPANY and the OFFICE OF INSURANCE REGULATION, the terms and conditions of which are set forth above, is APPROVED. FURTHER, all terms and conditions above are hereby ORDERED.


