NOTICE IS HEREBY GIVEN to the NATIONAL COUNCIL ON COMPENSATION INSURANCE, INC., and to all persons concerned that, pursuant to Section 627.111, Florida Statutes, a public hearing will be held in Senator Jim King Committee Room 401, Senate Office Building, in Tallahassee, Florida, beginning at 9:00 a.m. until conclusion, on August 16, 2016 for the purpose of considering the Workers' Compensation filing made by the National Council on Compensation Insurance, Inc. ("NCCI"), under the provisions of Section 627.091, Florida Statutes, and subject to the provisions of Sections 627.101 and 627.111, Florida Statutes.

This filing was received by the Office of Insurance Regulation ("OFFICE"), on May 27, 2016 and amended by NCCI on June 30, 2016.

In this filing, the NCCI requests an overall average increase in rate levels of 19.6% for the voluntary market for all new, renewal, and outstanding workers' compensation insurance policies written in the State of Florida, effective October 1, 2016.

All persons wishing to present expert testimony at this hearing must pre-file their testimony in writing with the OFFICE on or before August 9, 2016 attention, Anoush Brangaccio, General Counsel, Office of Insurance Regulation, 200 East Gaines Street, Tallahassee, Florida, 32399. Any expert witness failing to pre-file testimony may be prohibited from testifying.

PLEASE BE GOVERNED ACCORDINGLY.


