PURPOSE AND SCOPE OF EXAMINATION

Under authorization of the Florida Department of Financial Services, Office of Insurance Regulation, Bureau of Market Investigations, pursuant to Section 624.3161, Florida Statutes, a target market conduct examination of Royal Indemnity Company was performed by Norman Reitman Company, Inc. The scope of this examination covered first reports of unit statistical reports issued to the National Council on Compensation Insurance, Inc. (NCCI) in 2003 for policies written between May 1, 2001 and April 30, 2002. The examination began April 26, 2004 and ended May 07, 2004.

The purpose of this examination was to verify the accuracy and timeliness of unit statistical reports reported by Workers' Compensation insurers to the NCCI.

In reviewing materials for this report, the examiner relied on records maintained by the Company. The files examined were selected systematically from data files provided by the Company using Microsoft Excel's "random sample" selection process. The examination report is a report by exception. As a result, files or material reviewed containing no improprieties by the Company have been omitted from the examination report. Procedures and conduct of the examination were in accordance with the Market Conduct Examiner's Handbook produced by the National Association of Insurance Commissioners.

REVIEW OF UNIT STATISTICAL REPORTS

WORKERS' COMPENSATION

The current examination encompassed a review of Workers' Compensation Unit Statistical Reports including class codes and claims.

REPORT REVIEW

The following data is based on the review of fifty (50) policy files.

A. PREMIUMS:

One hundred sixty-eight (168) class codes were reviewed.

The total written premiums for the policy sample were \$5,453,466.

B. CLAIMS:

One hundred fifty-nine (159) claims were reviewed.

The total claims payments for the policy sample were \$671,025.

SAMPLE FINDINGS:

A. PREMIUMS:

Five (5) inconsistencies were noted.

Five (5) unit statistical reports were not corrected upon receipt of the final audit results. This resulted in under reports totaling \$6,482.

Corrective Action: The Company provided copies to the examiner of corrected unit statistical reports that were sent to NCCI.

B. CLAIMS:

No inconsistencies were noted.

CONCLUSIONS:

The review indicates that the premium inconsistencies fell within generally acceptable margins. Therefore, the Company is adhering to Florida Statutes.

The courtesy and cooperation of the officers and employees of the Company during the examination are acknowledged.
