THIS CAUSE is before the FLORIDA OFFICE OF INSURANCE REGULATION ("OFFICE") upon the filing of revised workers compensation rates and rating values by the NATIONAL COUNCIL ON COMPENSATION INSURANCE, INC. ("NCCI"). Following a complete review of the entire record, and upon consideration thereof, and being otherwise fully advised in the premises, the OFFICE hereby finds as follows:

1. On November 4, 2020, in response to the OFFICE's initial order docketed October 30, 2020, NCCI filed revised rates and rating values, modifying its original filing of August 27, 2020.
2. The revised filing provides for a statewide workers compensation insurance rate level decrease of 6.6 percent, and contains all other changes referenced in the OFFICE's initial order.

Accordingly, it is therefore ORDERED that NCCI's revised filing, in file log 20-020168, the terms and conditions of which are set forth above, is APPROVED.

NOTICE OF RIGHTS

Any party adversely affected by this Final Order may seek judicial review as provided in Section 120.68, Florida Statutes, and Florida Rule of Appellate Procedure 9.190. Judicial review is instituted by filing a notice of appeal with the Agency Clerk, and a copy of the notice of appeal, accompanied by the filing fee, with the appropriate District Court of Appeal. The notice of appeal must conform to the requirements of Florida Rule of Appellate Procedure 9.110(d) and must be filed (i.e., received by the Agency Clerk) within thirty (30) days of rendition of this Final Order.

Filing with the Office's Agency Clerk may be accomplished by U.S. Mail, express overnight delivery, or hand delivery. Facsimile transmissions and electronic filings are not accepted.
