To view these filings, go to the Filing Search page on our website: <http://www.floir.com/edms/>. Once you are there, you will need to use the search criteria displayed on the left side of the page. The most commonly used search criteria are the "file log #" and the "company name." To view a filing related to this rate hearing, type 11-12402, 11-12403, 11-12716 or 11-12717 into the file log # field, and the filing will be displayed. Alternatively, you can search by company name.

Due to the volume of individuals and entities using this I-File application, it will prompt you to enter your e-mail address. The application will assemble the document or the entire filing and e-mail it to you. This usually takes only a few minutes, but depends on the volume and size of the filing.
