PPACA Fees & Taxes

Beginning January 1, 2014, insurers will be required to pay several new fees as a result of PPACA. Among those fees are the Health Insurance Industry Fee (HIIF) that will help fund the federal and state exchanges. Another fee is the Reinsurance Assessment fee that will be collected from 2014 through 2016. Finally, the Comparative Effectiveness Research Fee (CERF) will be used to fund comparative effectiveness research.
