hereinafter referred to as "the Company." Such report of examination is herewith respectfully submitted.

SCOPE OF EXAMINATION

This was a limited scope examination of the Company as directed by the Florida Office of Insurance Regulation ("the Office"). The Company was last examined by representatives of the Office as of December 31, 2019. To the extent applicable, the limited scope examination was conducted in accordance with the guidance of the NAIC Financial Condition Examiner's Handbook, the NAIC Accounting Practices and Procedures Manual and the Florida Administrative Code. This examination was limited to particular risk areas of operational processes and the focus is less comprehensive than a full-scope examination. This report is for a limited scope examination and is not intended to communicate all matters of importance for an understanding of the Company's financial condition.

Fieldwork commenced on May 7, 2021 and concluded as of February 14, 2022. Our limited scope examination only included material events occurring subsequent to March 8, 2021. The focus of the examination was information technology related.

CURRENT EXAMINATION FINDINGS

There were no findings that met the criteria to be included in this Report.

CONCLUSION

The insurance examination included practices and procedures of a limited scope for Accredited Surety and Casualty Insurance Company, Inc. as of September 30, 2021, consistent with the insurance laws of the State of Florida. 
